Slightly fewer test takers passed the Missouri Bar Exam this year compared to last year, but overall numbers remain on an upswing compared to the COVID-19 pandemic.

This year 79.8 percent of 640 test takers passed the exam and 85 percent of first-time takers passed. Last year, 80.8 percent of 663 test takers passed the exam.

“Missouri kind of hit a low rate for passage [...] during COVID, and then it increased. I think this year maybe went down just a little bit again,” said Katherine Scannell, Washington University’s vice dean for institutional success. “But that’s such a small number of students. So it’s hard to read too much into that, but it’s much closer this year to last year’s results than in the prior covid space.”

The [Missouri Board of Law Examiners](https://www.mble.org/about-the-bar-exam) (https://www.mble.org/about-the-bar-exam) tests by administering the Uniform Bar Examination (UBE), which is comprised of the Multistate Essay Examination (MEE), the Multistate Performance Test (MPT) and the Multistate Bar Exam (MBE). According to Regulation 4 to Rule 8.08, prospective attorneys must obtain a score of at least 260 to pass the exam. The average test score for the July 2024 exam was 142.4 for the bar examination and 142.3 for the essay.

The highest UBE total score for the July exams was 354. For the MBE it was 181.5 and the essay was 179.8, according to the Missouri Board of Law Examiners.

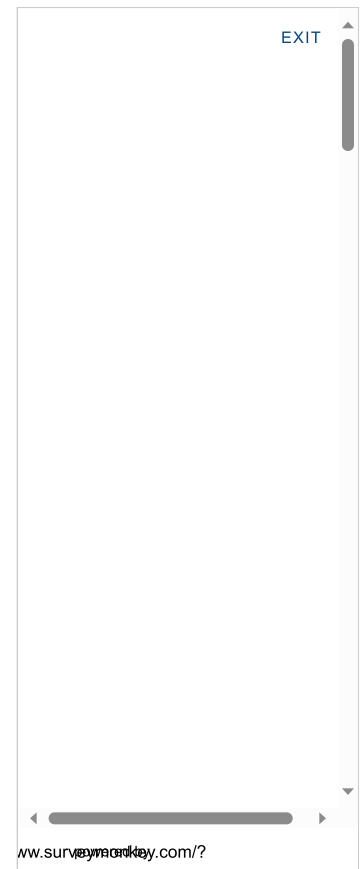
The lowest scores for these exams were 189 UBE, 95 MBE and 86.9 for the essay.

The July scores improved significantly from those seen In February where less than half of test takers passed the exam, Missouri Lawyers Media [previously reported](https://molawyersmedia.com/2024/04/11/fewer-than-half-of-february-bar-takers-pass-list-of-bar-passers/). February test takers tend to perform worse on average than those who take the test in July. Previously, the average score for the July exams dipped due to the COVID-19 pandemic but have since seen an upswing.

Washington University is particularly pleased with its results as its 51 students all passed the exam. This is the first time in a decade the institution has achieved a 100 percent passage rate, according to Scannell and Margaret Samadi, assistant director of the school's career center and bar success.

Scannell and Samadi formed a relatively new team this year to assist students with the bar exam post-graduation. Faculty at the school who have previous experience with the exam each have a cohort of students they assist with study plans and any issues they may encounter leading up to the bar.

“Each student has their own personal challenges that they deal with during the bar exam study period and some of those can be challenges they go into study knowing about, maybe test anxiety, but some of those could be things that are happening in their personal lives during the bar study period,” Scannell said. “Our approach this year was to create an individual strategy for each student and stay in contact with them, so we could help them face those challenges as they came up.”

University of Missouri-Kansas City Dean Lumen Mulligan said the institution also saw an increased success rate in the July results after it tried a new approach. The school’s first-time bar passage rate rose nine percentage points from last year to 90.6 percent.

“Last year, we made the choice to provide each and every one of our UMKC law graduates with a commercial bar prep program for them at no cost beyond their tuition and fees. And I think you’re seeing that big return,” Mulligan said. Additionally, Professor Wanda M. Temm leads UMKC’s bar pass program that is offered to students in conjunction with the course. This has been integral to students’ success on the exam, he said.

“We’re excited and happy to celebrate our success, not only for our UMKC grads but for all of the students who sat for the bar and succeeded,” he said.

Saint Louis University Professor Marcia Goldsmith said students who passed the exam were engaged with the school’s bar preparation offerings and were set up for success because of this.

“It really is in line with previous years. I know, all across the country, there was a dip because of COVID. We seem to be sort of climbing out of that dip,” she said. “So, we had a successful year, not quite as successful as last year, but still successful.”

Those who passed the July exam are eligible to participate in the enrollment ceremony on Sept. 27 at the Supreme Court of Missouri.
